- Pressley Ridge agrees to admit and treat all individuals without regard to race, color, national origin, religious creed, sex or handicap (except those conditions that may be limited by a state licensing agreement). All activities carried out by other organizations will be done in compliance with the 1964 Civil Rights Act, as well as any other applicable State or Federal laws or regulation governing discrimination in employment, service provisions, referral, or transfer.

TIME FRAME

This agreement shall be effective from the date of its execution until either party deems it necessary to terminate the agreement. Either party may withdraw with cause by giving thirty (30) days notice in writing to the other party of its intention to withdraw from this agreement.
